## From the Desk of Danielle Knapp, CIO Part 2: McKee Wallwork & Co Study

In 2011, a group of funeral homeowners had one question. "Who are our families, really?" They noticed the families they were serving were looking very different from the families they had served in previous decades. Their preferences were changing. The world was evolving. And they wanted to know why. Knowing they needed to work together, they pooled their resources and contacted a well-known market research firm, McKee Wallwork + Co (MW+C) in Albuquerque, NM. Funeral Directors wanted to know more about the families they were serving, who are they are. In doing so they could find ways to best serve each family knowing each one is different. MW+C conducted their first death care segmentation study to help this group of funeral homeowners get the answers they needed – and a few they weren't expecting. It has been over a decade since their first study. Last week we shared with you the first of five key findings. #### **Latest on the Colorado Return to Nature Case**

Return to Nature owners Jon and Carie Hallford were arrested Wednesday in Wagoner, Oklahoma, on charges of abuse of a corpse, forgery, theft and money laundering, the 4th Judicial District Attorney's Office announced in a news release. The Hallfords' Colorado arrest affidavits are sealed, but a federal arrest warrant filed by a Denver FBI agent on Tuesday provides new details about what investigators found when they searched the funeral home in October after receiving complaints of "a horrific odor of decomposing bodies."

The Fremont County Sheriff's Office was notified of the smell emanating from the building at 31 Werner Road in Penrose on Oct. 3, and the next day, a Colorado Department of Regulatory Agencies investigator spoke with Jon Hallford about gaining access to the building that day. Jon Hallford agreed to an inspection, stating he was using the building "to learn how to do taxidermy and he knew he had a problem there," according to the arrest warrant. ### Being Prepared for the Winter Months – Don't forget your vaccines!



It's challenging to make definitive predictions about the upcoming flu and RSV seasons. It's possible that they may return to pre-pandemic patterns, but it's also possible that other factors may come into play. Public health authorities will continue to monitor the situation and adjust their recommendations accordingly to protect public health. It's always a good idea to stay informed and follow the guidance of local health authorities.

"Just because we're coming out of the pandemic doesn't mean that we're suddenly immune to these other viruses, and we need to continue to do what we can to prevent those viruses from taking hold. #### **Childhood Vaccine Exemptions At An All Time High**

The vaccine coverage rates for school-aged children in the U.S. fell below the recommended 95% threshold. During the 2021-22 school year, the coverage was about 93%. The report also mentioned specific coverage rates for certain vaccines, such as 93.1% for MMR (Measles, Mumps, Rubella) and poliovirus, and 92.7% for DTaP (Diphtheria, Tetanus, Pertussis) vaccines. The increasing trend in exemptions and declining coverage rates is a public health concern and may lead to the resurgence of preventable diseases if not addressed through public health measures and education.
